

Paper 2: ORGANISATION AND SUPERVISION

- 1. (a) Using suitable headings prepare an ironmongery schedule and specification for a four bedroomed house.
 - (b) State **FOUR** uses for such a schedule.
 - (c) State **THREE** other types of schedule that an Architect might prepare for a larger contract.
- 2. Employees should be issued with a 'Contract of Employment'.
 - (a) List **TEN** items that the document should contain.
 - (b) State what is meant by "continuous employment", and how this affects an employee's rights relating to dismissal.
 - (c) The contract may refer to "The Working Rule Agreement" of the Building Industry. Indicate how this agreement relates to employee's rights and state why it is referred to in a Contract of Employment.
- 3. With reference to a Bill of Quantities.
 - (a) Explain using examples where appropriate, how each of the following would appear:-
 - (i) Provisional Sums. (ii) Prime Cost Sums.
 - (b) List **SIX** items that may appear in the preliminaries section.
 - (c) State the purpose of the "preamble" to each of the Trade sections.
 - (d) Define the terms.
 - (i) Taking off; (ii) Abstracting; (iii) Working-up.
- 4. The Health and Safety at Work etc. Act 1974 refers to obligations of Employers, Employees and the Self-employed. Relating to this Act explain:-
 - (a) The duties of the following:-
 - (i) Employer; (ii) Employee.
 - (b) The term 'At work' in relation to the following:-
 - (i) Employee; (ii) Self-employed person.
 - (c) The meaning of the phrase "Reasonably Practicable".

5.	Explain how quality control and the maintenance of high standards of workmanship is best achieved in the :-
	(a) Protection of materials prior to use;
	(b) Protection of completed work relating to :-
	(i) Floors; (ii) Door Frames/Linings;

(c) Testing of materials.

(iii) Stairs;

6. (a) List the advantages and dis-advantages of using Sub-Contracted labour on a large contract.

(iv) Work Tops and Units.

- (b) Define the term "Nominated Sub-Contractor".
- (c) Explain the difference between "Selected Tendering" and "Open Tendering".
- 7. Severe wood rot has been discovered in the ground floor of a house which has stood empty for some time. The new owner has requested an investigation to determine the extent of the problem.
 - Prepare a report on the infestation, remedial measures recommended and approximate costs.
- 8. The current Building Regulations state that "Stairways should be such as to afford safe passage for the users of the building". A client has queried how a stair for a private dwelling would comply with this regulation.
 - With the aid of sketches, formulate a reply to this query with reference to the "approved document on stairs".
